AMPP Fellow Honor

Award Description:

Recognizes an individual for outstanding technical achievement in the field of materials protection and performance over the course of a career, with significant contributions to mentoring and/or policy efforts, and for being an inspiring leader for the Association members.

Only those who have made extraordinary and outstanding contributions to a scientific or technical body of knowledge -- over a lengthy career -- receive this honor. The Fellow Honor is awarded in recognition of distinguished contributions of an AMPP member that may be in any of the following areas:

- Advances in corrosion science, corrosion engineering, or corrosion control,
- Raising awareness of materials degradation,
- Actively increasing inclusion and diversity in the field,
- Notable educational or research-related activities, and
- Mentoring or advancing others in the field.

Together, AMPP Fellows develop a broadly based forum of industry expertise and may serve as advisers to the Association. AMPP Fellows who accept their nomination are anticipated to be actively involved in future mentoring and social benefit activities following their recognition.

One Award per Year: A nominee is only eligible to receive one (1) award each calendar year. However, an individual may receive the Fellow Honor in addition to any other award in the same year.
